Audiology Protocol - Speech Audiometry

- Test names: Speech perception, speech audiometry
- Purpose: To determine ability to perceive speech or speech-like stimuli; to aid in determination of pure tone threshold reliability; includes speech awareness, speech discrimination, and speech recognition determinations.
- Population Intended: children at and above approximately 6 months developmental age
 - Expected Outcome: quantification of speech perception ability bilaterally
 - Practice Guidelines:
 - A. Test area: Testing should be carried out in a quiet area. A clinical test booth is not required as long as ambient and environmental noise is maintained at a low level.
 - Calibration Sound booth meeting ANSI S3.1 (1999) ears not covered (500-8000Hz) specifications, and earphone calibration (ANSI, 1996).
 - C. Procedures -
 - Use of insert earphones coupled to foam eartips or child's personal earmolds, supra-aural earphones, bone vibrator, or sound field testing as determined by specific circumstances or test needs.
 - 2. Prior to obtaining thresholds to frequency-specific stimuli, a threshold for speech should be obtained. Speech reception thresholds (SRT) are typically obtained using developmentally-appropriate spondee words. Responses can be made orally or by picture pointing. Picture pointing should be used if the child's speech production abilities are compromised. If picture cards are used, examiner should have child point to each picture upon request prior to starting the test. If the child is unable to point to the pictures, the examiner should consider modifying the protocol (e.g., point to body parts). If procedure is still unsuccessful, speech awareness threshold (SAT) should be obtained.
 - A systematic bracketing protocol with audible starting level, and pre-determined step-sizes is recommended when speech thresholds are being obtained; step sizes and start/stop rules should be consistent with those used for obtaining pure tone thresholds for children of the same age;
