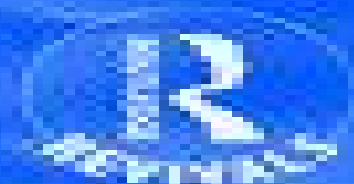

law whose interactions with Union law are merely of an indirect nature However in addition to this well known account of EU law a parallel yet distinct narrative can be identified according to which SNAs are insiders that entertain direct relations with the European Union and contribute to the substantive development of EU law It is illustrated that the coexistence of both narratives has wider implications as it points towards a shift in the structure of the European legal order itself which is transitioning from bi centrality to polycentricity
