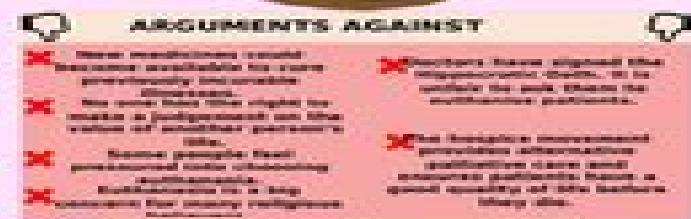
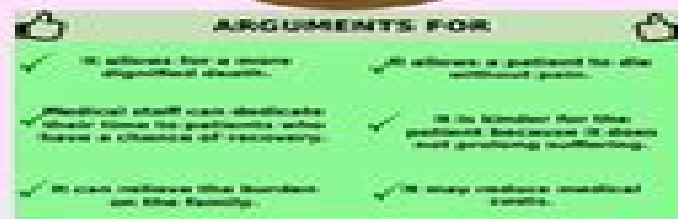


# Euthanasia

## RELIGIOUS

The Catholic Church is strongly opposed to euthanasia and believes that it is a crime against life.

### JUDAISM

"There is no God besides me. I will be death and I bring the life." Deuteronomy 32:39

Only God has the right to give life and take it away, even when it has become a burden rather than a blessing.

Although Judaism is opposed to voluntary euthanasia and suicide, some Jewish people believe that passive euthanasia or permissibility of further treatment to going to reduce suffering.

### ISLAM

"We are all the breath of God's hand, and I have forbidden." Surah 5:145

All human life is given by Allah, and Allah decides how long each person will live. Life is a test, and those who are suffering should turn to Allah.

However, in circumstances where death is inevitable, the patients should be allowed to die without unnecessary procedures.

### HINDUISM

"The one who tries to escape from the bonds of life by committing suicide will suffer even more in the next life." Yajur Veda 40:43

Euthanasia causes the soul and body to be separated at an unchosen time, disrupting the timing of the cycle of death and rebirth.


