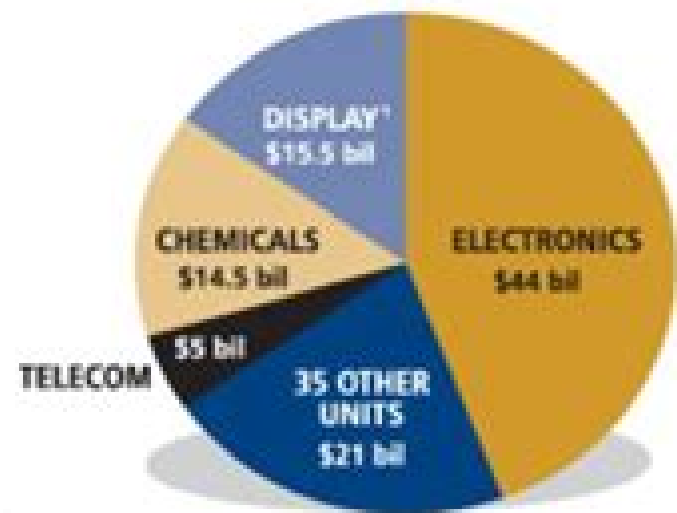
Share of Top 30 Chaebols in South Korea's GDP
