#### Financial Reporting of Interests in Joint Ventures

(In this Accounting Standard, the standard portions have been set in bold italic type. These should be read in the context of the background material which has been set in normal type, and in the context of the 'Preface to the Statements of Accounting Standards' <sup>2</sup>.)

Accounting Standard (AS) 27. Financial Reporting of Interests in Joint Ventures', issued by the Council of the Institute of Chartered Accountants of India, comes into effect in respect of accounting periods commencing on or after 01.04.2002. In respect of separate financial statements of an enterprise, this Standard is mandatory in nature if from that date. In respect of consolidated financial statements of an enterprise, this Standard is mandatory in nature if where the enterprise prepares and presents the consolidated financial statements in respect of accounting periods commencing on or after 01.04.2002. Earlier application of the Accounting Standard is encouraged. The following is the text of the Accounting Standard.

#### Objective

The objective of this Statement is to set out principles and procedures for accounting for interests in joint ventures and reporting of joint venture assets, liabilities, income and expenses in the financial statements of venturers and investors.

#### Scope

- This Statement should be applied in accounting for interests in joint ventures and the reporting of joint venture assets, liabilities, income and expenses in the financial statements of venturers and investors, regardless of the structures or forms under which the joint venture activities take place.
- The requirements relating to accounting for joint ventures in consolidated financial statements, contained in this Statement, are applicable only where consolidated financial statements are prepared and presented by the venturer.

#### Definitions

For the purpose of this Statement, the following terms are used with the meanings specified:

A joint venture is a contractual arrangement whereby two or more parties undertake an economic activity, which is subject to joint control.

<u>Joint control</u> is the contractually agreed sharing of control over an economic activity.

Control is the power to govern the financial and operating policies of an economic activity so as to obtain benefits from it.

A venturer is a party to a joint venture and has joint control over that joint venture.

An investor in a joint venture is a party to a joint venture and does not have joint control over that joint venture.

Proportionate consolidation is a method of accounting and reporting whereby a venturer's share of each of the assets, liabilities, income and
