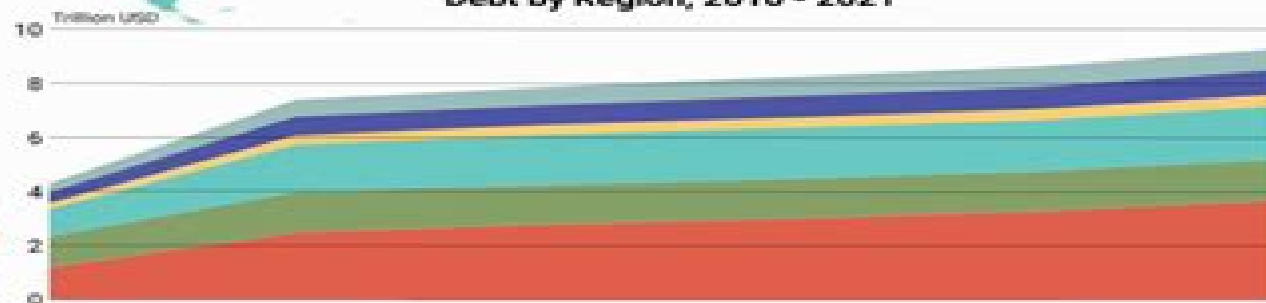


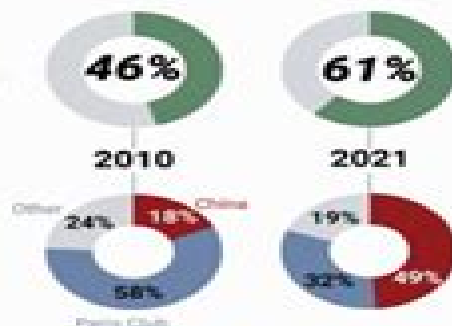

Debt by Region, 2010 - 2021



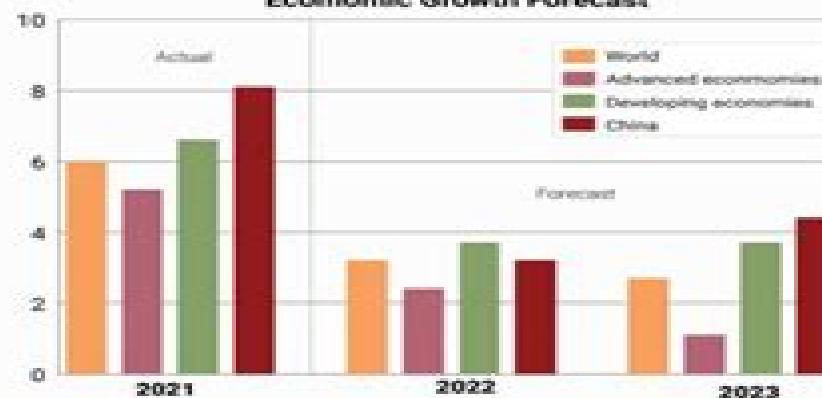
Debt to Private Creditors
