

Section 5.1 – Identifying a business combination (pg 223)

- Definition: A transaction or other event in which an acquirer obtains control of one or more businesses
 - o E.g. Buying a franchise from the franchisors; true mergers; mergers of equal
- The acquired business is subsequently sold to other parties do not indicate that a business combination did not take
 place on acquisition date, they just show that the business combination was short lived.
- Direct and indirect acquisition (See section 5.3)



Section 5.2 – Acquisition method (pg224)

IFRS 3- requires all businesses combinations within the scope of the standard to be accounted for using the acquisition method.

Except: business combination involving businesses or entities under common control (outside scope)

The acquisition method is applied at acquisition date.

Step 1: Identify the acquirer	Step 2: Determine acquisition date
The acquirer is usually the entity that: - Transfers the cash or other assets - Incurs the liabilities	The date on which the acquirer obtains control of the acquirees
 Issues the equity interests Larger in size than the acquired company 	Direct – date when the contract of the sale of the business by acquiree is signed
 Initiated the combination A new entity formed to effect a business combination is not necessarily the acquirer; one of the combining entities should be identified as the acquirer. 	Indirect – date when enough shares in the acquiree that give majority voting power are held by the acquirer
