have also been some serious costs white flight and protest voting associated with forced busing and the use of strict racial quotas The concluding chapter argues that the solution to racial disparities in achievement and to racial separation lies in compensatory education for low achieving poor children and school choice programs that do not use racial criteria but provide financial assistance to low income families
