

# Involuntary Terminations Procedures

**1**

- Before any action is taken to involuntarily discharge an employee, the employee's manager must request a review by HR and the employee's immediate supervisor

**2**

- The termination review staff will be responsible for reviewing the circumstances and determining if discharge is warranted. If the staff recommends discharge, the employee's manager and an HR representative will notify the employee

**3**

- The employee's manager should complete an Employee Change Form and notify HR and payroll of the last day worked by the employee
