The *Handbook* is a joint undertaking by the Bank for International Settlements (BIS), the European Central Bank (ECB), and the International Monetary Fund (IMF). They have specific interests and expertise in the area of securities statistics and are the core members of the Working Group on Securities Databases (WGSD). In 2007, the WGSD, originally established by the IMF in 1999, was reconvened in response to various international initiatives and recommendations to improve information on securities markets. The WGSD is chaired by the ECB and includes the BIS, the IMF, and the World Bank. Selected experts from national
