competence The author is convinced that healthcare allocation is also an ethical issue that needs to be governed by ethical principles The key factors for choosing this theme are based on the author's knowledge of the deplorable condition of the health care system in Nigeria and his desire to save human lives Rev Fr Anthony Okechukwu Nnadi believes that we are all stewards of human life This implies a moral obligation to protect the dignity of the human person which is inseparable from protecting human life
